PLEASE PROVIDE A COPY OF A TAX RECEIPT OR DEED SHOWING REAL ESTATE OWNERSHIP, IDENTIFYING THE PRECISE LOCATION BY ADDRESS WITHIN THE DISTRICT. YOU MUST PROVIDE A PHOTOCOPY TO THE POLL WORKER WHICH WILL BE KEPT BY THE POLL WORKER.

IF THE PROPERTY IS OWNED BY A PARTNERSHIP, LIMITED PARTNERSHIP, CORPORATION, ESTATE OR TRUST ("ENTITY VOTER"), PLEASE PROVIDE EVIDENCE THAT THE PERSON VOTING ON BEHALF OF THE ENTITY VOTER HAS AUTHORITY TO ACT ON BEHALF OF THE ENTITY VOTER. YOU MUST PROVIDE A COPY TO THE POLL WORKER WHICH WILL BE KEPT BY THE POLL WORKER.

ONCE YOU HAVE COMPLETED VOTING, PLEASE PLACE THE PAPERWORK MENTIONED ABOVE INTO THE BALLOT ENVELOPE ALONG WITH YOUR VOTED BALLOT. PLEASE TEAR OFF THE TAG ON THE FLAP OF THE BALLOT AND RETAIN THE ENVELOPE NUMBER ON THE FLAP.

YOU MAY CALL INTO THE BOARD OF ELECTION COMMISSIONERS (314-622-4336) WITHIN ONE WEEK OF THIS ELECTION TO DETERMINE WHETHER YOUR BALLOT WAS COUNTED.

**EACH QUALIFIED VOTER  
SHALL HAVE ONE VOTE.**

- IF THE SAME PERSON OR ENTITY OWNS MORE THAN ONE PIECE OF PROPERTY WITHIN THE DISTRICT, THEY SHALL NEVERTHELESS HAVE ONLY ONE VOTE.
- AN INDIVIDUAL WHO IS A REGISTERED VOTER WITHIN THE DISTRICT AND ALSO OWNS REAL ESTATE IN THE DISTRICT SHALL ONLY HAVE ONE VOTE.
